Suffolk Constabulary and PCC: £1.6m for Safer Streets across Suffolk



Making Suffolk a safer place to live, work, travel and invest

Following a successful bid to the Home Office, the Police and Crime Commissioner for Suffolk has secured over £990k from the Safer Streets 5 Fund to support a variety of initiatives to address anti-social behaviour, violence against women and girls, and neighbourhood crime across Suffolk. Match funding and in-kind contributions from partners will make this up to over £1.6m over two years.

Suffolk's Police and Crime Commissioner Tim Passmore said:

"This is undoubtedly excellent news for Suffolk and once again demonstrates how the power of collaboration with community safety partners benefits our county. Whilst Suffolk is one of the safest areas in the country nevertheless there are specific areas where much more needs to be done to tackle and prevent crime and anti-social

I really believe the Safer Streets 5 funding will have a very positive impact on community safety and therefore help improve the quality of life for homes and businesses in these areas.

The previous three successful bids clearly demonstrate how targeted initiatives can act as a strong catalyst for permanent change – in short a great result for us all.

East Suffolk Council has been allocated £333,887 to fund higher quality CCTV cameras in Lowestoft, provide outreach activities for young people, who have been excluded, or who are at risk of being excluded, who are perpetrating, or at risk of perpetrating, ASB and neighbourhood crime.

Ipswich Borough Council's allocation of £333,300 will be focused on a number of hotspot areas across the town which experience sustained anti-social behaviour. These include small shopping parades, churchyards, riverside areas and areas within the town centre. This will include CCTV, Crimestoppers Zones, an ASB awareness campaign, improved lighting in public spaces, better gating and fencing, youth and adult outreach support and environmental improvements.

Funding of £323,836 will focus on increasing the feeling of safety and personal security for residents and visitors in west Suffolk by focusing on violence against women and girls, anti-social behaviour and acquisitive crime. This will fund CCTV improvements, educational outreach work with young people targeting behaviour and attitudes and the impact on victims, environmental improvements, training and awareness on Violence Against Women and Girls and ASB, and target hardening measures such as property marking, home security and awareness raising. The chosen interventions for each crime time will be targeted to specific geographic areas within Bury St Edmunds,

Haverhill, Newmarket, Sudbury and Stowmarket, Mildenhall, Brandon, Cornard and Needham Market.

The Home Office funding of £991,023 was conditional on partner contributions to the total of 50% of the funding granted. Match funding of £706,649 has been generated through a contribution from the Pooled Business Rate fund of £150k and in-kind contributions from each local authority, Suffolk County Council, Suffolk Constabulary and the Office of the Police and Crime Commissioner.












Scheme Coordinators: Registering your scheme on the national database



if you haven't already done so, we highly recommend all our scheme coordinators and their members to register individually on the national Neighbourhood Watch Network website.

We will continue to process the mapping of all schemes registered with the Suffolk Neighbourhood Watch Association (SNWA) onto the National NW database. This enables the public to search for Neighbourhood Watch schemes on the national website as well as our own website.

Whilst not mandatory, we do encourage Scheme Coordinators registered with us to also register on the national database, which will enable them to "claim" their scheme on the national system.

Scheme Coordinators registered on the national database are approved and validated by the Suffolk Neighbourhood Watch Association.

Once registered, scheme coordinators can invite existing and future neighbours to join their scheme online, and use the built in ALERT message system as a method of engaging with their scheme members.

Benefits of registering:

Scheme coordinators and members can expect to receive a monthly newsletters from both the national organisation, as well as the Suffolk Association. Members can also access a range of training workshops, seminar sessions, and varying forums offered by the national organisation. When signing up, members can also opt in to receive a range of alert messages from services such as Action Fraud, Get Safe Online, Trading Standards etc.

Suffolk Trading Standards: Trusted Trader



Suffolk Trading Standards has partnered with Trusted Trader to launch a scheme in Suffolk where traders can sign up to be accredited members of a trusted trader scheme.

The scheme then allows residents of Suffolk to log on and find traders they can trust to carry out services in our local area.

It is the only TS accredited scheme in Suffolk.

The aim is to empower consumers to make good choices when getting quotes and choosing traders to carry out services for them, potentially reducing the amount of doorstep calls and unnecessary work affecting residents in our county.

Launched during September, the website is still onboarding traders but it is expected to be populated with many sectors soon.

Promoting communities to consider using accredited traders is likely to go some way to help prevent unsolicited trading in Suffolk.
